

## Junior Team Vitality application form

A Junior Team Vitality club member refers to a child from the age of 16 to 18 listed as a dependant on your Vitality membership.

### What the benefit offers

Team Vitality is South Africa's most rewarding running club. For your membership fee, you'll get:

- A premium running race kit
- Delicious food, fruit, coffee and drinks from Woolworths, including a warm sense of community, after select races at our VIP hospitality tent
- 50% off your Strava subscription
- 25% off your In-Case-of-Emergency Identification (ICE ID) bracelet

### Who may use the benefit?

Members from 16 to 18 years old with an active Vitality membership can register with Junior Team Vitality. They can join the Junior Team Vitality movement at any time during the year. Their membership is valid for one calendar year and it will end automatically on 31 December each year.

Junior Team Vitality does not auto-renew.

The annual membership fee is R360 consists of an activation fee of R225 and an ASA licence of R135.

You can only activate their benefit if they are in one of our licensed regions: Central Gauteng, Gauteng North, KwaZulu-Natal, Eastern Cape, Western Cape and the South Western District.

### Entering races

Once you have selected the race you want your child to participate in, you will need to enter through the event website, not the Team Vitality website, and pay the race entry fee directly to the race organisers.

All members aged 14 to 17 who are part of the Vitality Active Rewards for Teens programme and who completed a fitness activity, will earn a play on the game board for that following week.

By getting active through partner workouts (at Virgin Active or Planet Fitness gyms, and parkrun events) and outdoor race events, kids can earn up to 25 Discovery Miles per activity. The amount of Miles they can earn in a month is capped at 200 Miles.

When your child turns 18, they can remain on the benefit for the remainder of the year, thereafter they will not be eligible for the Junior Team Vitality benefit.

### When this benefit ends

Your child will have access to this benefit until the end of the calendar year in which they joined. They will have to activate the benefit at the beginning of each calendar year if they want to remain part of the Junior Team Vitality movement. The benefit will end if your Discovery Vitality membership is no longer active or the child turns 18 years old.
