

Terms and conditions for the Vitality HealthyCare spend drive competition

2. The competition will run from **9 June 2026**, with a deadline for entry at midnight on **13 July 2026** ("**Competition Period**").

The competition and who qualifies

1. This competition is open to all South Africans that are 18 years or older, Vitality members who meet the following criteria:
 - Vitality HealthyCare benefit has been activated before the time the competition ends.
 - Members must purchase at least one (1) qualifying HealthyCare product from either Clicks or Dis-Chem (online or instore) during the competition period (9 June to 13 July 2026).

3. Each successful transaction must include a swipe of the member's Clicks ClubCard or Dis-Chem Better Rewards card linked to Vitality via their South African ID or passport number to earn rewards and enter the draw.

6. Purchases can be made either instore or online.
