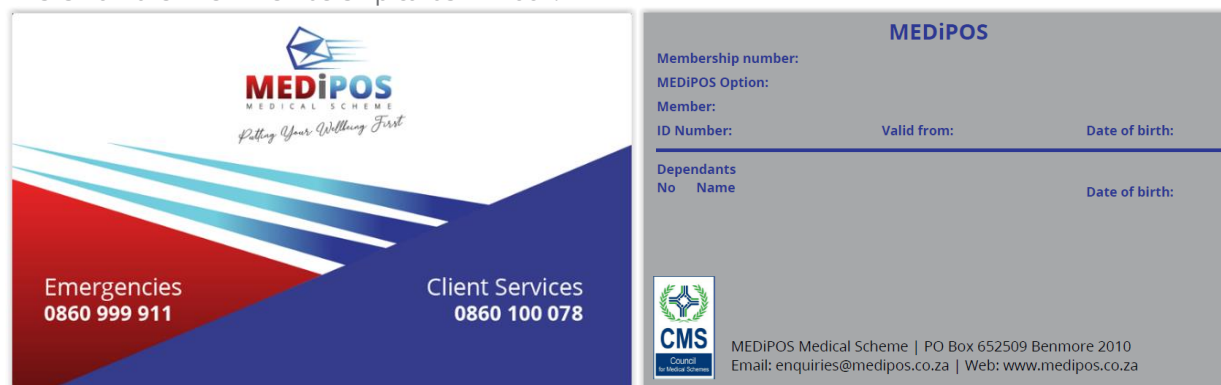
We are pleased to let you know that MEDiPOS Medical Scheme will be administered by Discovery Health from 1 April 2025.

To make sure that you and the members of MEDiPOS Medical Scheme experience a smooth changeover, please read the information in this letter.

How to identify MEDiPOS Medical Scheme members

Discovery Health will issue new membership cards to all MEDiPOS Medical Scheme members so you can identify them as valid members.

This is how their new membership cards will look:



Submitting claims up to 31 March 2025

- Please send all claims for MEDiPOS members up to and including 31 March 2025 to Mediscor, the previous Pharmaceutical Benefit Manager.
- Any claims for 2024 must be sent via the existing channels to the previous administrator, Medscheme.
- Please refer to the correspondence from Mediscor about the specific timelines and the last date of submission.

Submitting claims from 1 April 2025

From 1 April 2025, all claims from 1 January 2025 should be submitted to Discovery Health.

- Any claims for **service dates after 1 April 2025** must be submitted to **Discovery Health using the new MEDiPOS Medical Scheme membership number** on the newly issued MEDiPOS cards.
- **Claims that your practice has not previously submitted to Mediscor.** Any claims for service dates from 1 January 2025 to 31 March 2025 that you have not yet submitted on-line to Mediscor must also be submitted to Discovery ProPBM from 1 April 2025 using the members **new MEDiPOS Medical Scheme membership number**.

- The submission codes are the same for all networks.
- Rates apply to both chronic and acute medicine.
- Reference pricing applies and will be flagged with reason codes and clarifying messages
